Scholarship Application of the Grace United Methodist Foundation including -Cecil Bolsinger Scholarships -Heather Hartline-Funaro Scholarship

Criteria used by the Foundation Scholarship committee to determine scholarship winners:

- Member of Grace United Methodist Church.
- Family member/child of a staff member of Grace UMC.
- The applicants level of activity at Grace UMC, i.e. - if youth, their activity level in general Church activities and youth related activities.
- Prior year awarding of Foundation scholarships is considered neither a benefit nor a negative, except that the maximum number of scholarship awards, given to any single person has been capped at four times.
- It is not primarily based on the economic need of the student, but perceived economic need is one of the factors.
- Also recognized that students while away at school, would not be active in church or church related programs, this would not be a detriment, their activity level from previous years (i.e.-youth program, choir, etc) would count as their Church activity level.
- Any post secondary accredited school, trade, college, or university is eligible.
- Under IRS guidelines awardees cannot be related to a member of the GRace UM scholarship committee.

Requirements to obtain scholarship dollars after an award:

- The award is divided into two 50% installments, to be paid ½ during first semester and ½ during second semester.
- Proof of enrollment is required for each semester.
- A class list, tuition billing statement, enrollment letter from school are all acceptable forms of proof of enrollment. These are generally always available by August for the fall term, and December for the spring term.
- Photocopies/scans can be mailed or emailed to the Chairperson of the Scholarship committee.
- If mailed to the church office, please mark it to the attention of: Chairperson of Scholarship Committee.
- Unclaimed scholarships (i.e., no proof of enrollment) after one year will go back into the foundation. They will not be re-awarded.
- Un-cashed scholarship checks that remain un-cashed after 12 months will be voided.
- Once acceptable proof of enrollment has been received, the request for remittance will be sent to the foundation treasurer for the issuance of funds. These funds will be paid directly to the scholarship winner, not to the college/educational facility. Scholarship winners should consult their tax advisor for any tax consequences.
